# WHEN TO SHIP:

Advance rate deadline is March3rd. Shipments received thereafter, standard rate will apply.

However, shipments consigned to the warehouse after SHOW SITE STAGING has opened, an additional 50% special handling fee will apply. Shipments consigned to SHOW SITE must arrive 2 days prior to your set-up date. Staging opens March 10th. Show Site shipments, all carriers are required to check in at staging located at 1111 N Congress Avenue, WPB, FL 33409 before allowed on the property to be unloaded.

COLLECT SHIPMENTS OR LOOSE OR UNCRATED MATERIALS WILL NOT BE ACCEPTED.
