BEFORE SHIPPING:

WHEN TO SHIP:

Advance rate deadline is March 1st. Shipments received thereafter, standard rate will apply. However, shipments consigned to the warehouse after SHOW SITE STAGING has opened, an additional 50% special handling fee will apply. Shipments consigned to SHOW SITE must arrive 2 days prior to your set-up date. **Staging opens March 11th.** On Show Site shipments, **all carriers are required to check in at staging located at 950 Evernia Street, WPB, FL 33401** COLLECT SHIPMENTS OR LOOSE OR UNCRATED MATERIALS WILL NOT BE ACCEPTED.
